Section 21 applies to anybody who has been sentenced to imprisonment or to youth custody or detention in a young offender institution for three months or more. The period for which they are prohibited depends on their length of sentence if the sentence was longer than three years, the prohibition is for life. If the sentence was three months or more, but less than three years, the prohibition lasts for five years from the date of their release.
